

Appendix 1 International Organizations and Abbreviations

I. Some international organizations and the members included are as following,

Organization for Economic Co-operation and Development (OECD), has 38 members, i.e., Australia, Austria, Belgium, Canada, Chile, Columbia, Costa Rica, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Israel, Italy, Japan, Korea, Latvia, Lithuania, Luxembourg, Mexico, Netherlands, New Zealand, Norway, Poland, Portugal, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, Turkey, United Kingdom and United States.

European Union (EU), it expanded to 27 members, i.e., France, Germany, Italy, Netherlands, Belgium, Luxembourg, Denmark, Ireland, Greece, Spain, Portugal, Austria, Finland, Sweden, Cyprus, the Czech Republic, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Slovakia, Slovenia, Bulgaria, Romania and Croatia.

European Monetary Union (Euro Area), it has 21 members and member countries are Germany, Belgium, Austria, Netherlands, France, Italy, Spain, Portugal, Luxembourg, Ireland, Finland, Greece, Slovenia, Cyprus, Malta, Slovakia, Estonia, Latvia, Lithuania, Croatia and Bulgaria.

Association of South East Asian Nations (ASEAN), it has 11 members, i.e., the Philippines, Malaysia, Thailand, Singapore, Indonesia, Brunei Darussalam (1984), Viet Nam (1995), Myanmar (1997), Lao People's Democratic Republic (1997), Cambodia (1999) and Timor-Leste(2025).

North American Free Trade Area(NAFTA), was founded on January 1, 1994, with members unchanged hitherto, i.e., Canada, Mexico and the United States.

Group 7, includes the United States, Japan, the United Kingdom, Germany, France, Italy and Canada.

II. Countries (territory) groups and their meanings are as following,

Countries by Income Group According to the criteria by the World Bank, countries and territories (referred to as economies) are classified into high income (higher than \$13,935), upper middle income (between \$4,496 and \$13,935), lower middle income (between \$1,136 and \$4,495) and low income (\$1,135 and below) groups by their per capita GNI (calculated by Atlas method) in the year 2024.

Developed and Developing Countries or Areas There is no established convention for the designation of "developed" and "developing" countries or areas in the United Nations system. In common practice, Japan, Cyprus, Israel in Asia, Canada, the United States, Bermuda, Greenland, Saint Pierre and Miquelon in northern America, Australia, New Zealand, Heard Island and McDonald Islands, Norfolk Island, Cocos (Keeling) Islands, Christmas Island in Oceania, and Europe are considered "developed" regions or areas. The classification updated in May 2022 reflects that the Republic of Korea is considered part of the developed region. Advanced economies in International Monetary Fund (IMF) are composed of 42 countries: Andorra, Australia, Austria, Belgium, Canada, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hong Kong SAR, Iceland, Ireland, Israel, Italy, Japan, Korea, Latvia, Liechtenstein, Lithuania, Luxembourg, Macao SAR, Malta, Netherlands, New Zealand, Norway, Portugal, Puerto Rico, San Marino, Singapore, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, Taiwan Province of China, United Kingdom, and United States. Others are emerging markets and developing economies.
